Woods Campground Perm - Golf Cart Contract

- Cart owner(s) shall be legally and financially responsible for the operation of their golf cart including any damages that result from operation of the golf cart by the owner and or their authorized or unauthorized operators.
- Golf cart shall be secured at all times as to prevent unauthorized use and theft.
- Golf carts must be registered and have a valid registration sticker attached to the driver's side of the front of the car.
- Proof of proper liability insurance must be shown with a minimum of \$50,000 coverage in Personal Injury and Property Damage held on the golf cart. Cart permit is void if insurance paperwork on file has expired.
- There is a \$25 charge for the registration sticker and annual registration renewal.
- Driver must have a VALID state government issued driver's license in their possession to operate a golf cart. Operator must be able to provide said license immediately upon demand.
- No gas powered golf carts are permitted. All golf carts must be maintained properly and are subject to inspection.
- Golf carts operating after sunset must have lights turned on. Properly functioning front headlights and rear tail lights must be permanently attached. A flashlight or bicycle lights are not adequate.
- Golf carts must be operated safely and driven only on roadways or designated paths. Golf carts are not to be driven on steep or uneven paths or across vacant or occupied campsites or in other restricted areas.
- Driving under the influence of any impairment substance is strictly prohibited. Walk – it's not that far.
- The maximum number of people on a golf car shall be no more than for what permanently attached seating is intended.
- Uninsured, inoperable, hazardous or leaking golf carts must be promptly removed from the campground. Perm Camper shall have 48 hours to remove Golf Cart from premises upon determination of any of the aforementioned conditions after which management shall remove golf cart at the risk and expense of the Perm Camper.
- Each authorized operator must attend annual low speed acquisition training in order to retain valid permit.
- The Woods Campground shall not be held liable for theft or damage of golf cart.

Golf Cart Penalties:

- First Offense of reckless driving: \$50.00 fine (no warnings)
- Second Offense of reckless driving: \$100.00 fine or removal of cart for 60 camp season days.
- Third Offense of reckless driving: \$100.00 fine AND removal of cart for 182 camp season days.
- Additional offences will result in loss of perm site or ability to reserve campsites.
- Use of cart shall be prohibited until fines are paid in full. Fines unpaid after 5 days shall result in removal of cart from campground and shall incur additional fine of \$2/day until fine is paid in full.
